Memorandum of Understanding

Between

Dhanraj Baid Jain College,

&

Mahindra Pride School

For training students under CSR's Youth Employability Initiative

This Memorandum of Understanding is made at Chennai on 10th day of August 2017.

BETWEEN

Dhanraj Baid Jain College, located at Jyothi Nagar, Thoraipakkam, Chennai-600097, herein after referred to as "**D.B. Jain College**" (Which term shall so far as the context admits be deemed to mean and include its successors and assigns) of the **First Part**,

AND

M/s. Mahindra Pride School, Naandi Foundation a **Public Charitable Trust incorporated under the Indian Trusts Act, having its registered office at 502, Trendset Towers, Road No 2 , Banjara Hills, Hyderabad – 500 034, Telangana** , herein after referred to as “MPS” (which term shall so far as the context admits be deemed to mean and include its successors, administrators, executors and assignees) of the **Second Part**.

WHEREAS:

1. **Dhanraj Baid Jain College (Autonomous)** is affiliated to University of Madras ,Chennai. Dhanraj Baid Jain college offers Degree programmes in the various fields of Arts & Science like B.Com, BBA, BSc, BCA etc.
2. MPS is a Training Partner for providing training to the students under the CSR initiative of the Mahindra Group
3. **Dhanraj Baid Jain College** is willing to enter into a Memorandum of Understanding (MOU) with MPS to train its students under the aforesaid CSR Initiative Program that will train and make the students employable.
4. This MOU is entered for the first time since the Programme was already started. The training program is a MPS funded program for the social cause.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. Objective:

The objective of this MOU is to train the students under the CSR-Initiative program, (hereinafter referred to as the “Training Program”) to be conducted at **Dhanraj Baid Jain College** premises.

2. Period of MOU:

This MOU shall come into force with effect from the date of execution and shall remain valid for a period of Three years from such date after which the same may be reviewed by either party. However, if the same is not renewed this arrangement will be deemed terminated on the expiry of the said duration period.

Mahindra Pride School conducted Free Training Program to the Final Year Students of D.B.Jain College from 2016-17 onwards.

3. Roles & Responsibilities of Dhanraj Baid Jain College :

- a. Dhanraj Baid Jain College shall be responsible to nominate one person with adequate accountability and responsibility to coordinate the Training Program. The person so appointed would act as the single point of contact (SPOC) for the proposed Programme.
- b. It would be the responsibility of Dhanraj Baid Jain College to ensure that proper publicity of the Program is made through College website.
- c. To encourage the Students to register for the Program by informing them about the benefits of the program.
- d. To make available the infrastructure (including IT infrastructure, applications and connectivity) required for conduct of the Training Program. The infrastructure requirements such as LCD projectors, classrooms, computer labs, PC with internet connectivity, etc., are provided by Dhanraj Baid Jain College based upon the availability of resources.
- e. To provide all the support services and facilities to MPS during the conduct of the said Training Program.
- f. To coordinate with MPS and facilitate the conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by MPS, as per schedule communicated by MPS .
- g. Dhanraj Baid Jain College will have the absolute right to dismiss a candidate if the candidate does not align with rules and regulation of the institution, and of the state.

4. Roles & Responsibilities of MPS:

- a. MPS shall be responsible to provide the training as per Training Program requirements and curriculum for delivery.
- b. MPS will provide suitable faculty for conducting the training exclusively for classroom training.
- c. MPS will arrange for assessment of its own and also arrange external assessment as required.

5. Other Terms & Conditions:

Following are the other terms and conditions of MOU:

- a. **Batch Size:** The batch size would need to be a minimum of 40 students.
- b. Each student would be made available for the Training Program for specified number of hours per day for the entire duration of the Training Program.
- c. The students enrolled should complete the training as scheduled.
- d. Attendance will be responsibility of Dhanraj Baid Jain College.
- e. Program Coordinator to be appointed by college.
- f. Training & Placement Officer's active support and participation is required for the smooth and efficient conduct of the program.

6. Commercials:

This Training Program is free of cost. MPS shall not charge any fees on whatsoever account/name from the students of Dhanraj Baid Jain College for conducting the aforesaid training program.

7. Certification:

Certificates shall be awarded by MPS to the students on successful completion of the training and clearing of the assessment held post-completion of the training program,

8. Limitations and Warranties :

Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MOU terms by either party.

9. Termination:

- a. Both parties can terminate the MOU with a prior written thirty (30)-day notice on default of terms or non-adherence to any condition or responsibilities by the other party as outlined in this MOU in case such default or non-adherence is not rectified within such 30 days.
- b. Both parties also agree and undertake that despite of any termination of the MOU, the progress of the ongoing Training Programs would continue without any hindrance and would be progressed for completion.

10. Entirety & Amendment:

This MOU contains the entire understanding between the Parties in relation to the Training Program. If during the operation of the MOU, circumstances may rise which call for alteration / modification to this MOU, such alteration / modification shall be mutually discussed and agreed upon in writing. Such changes will be formalized in writing as an 'Addendum' to this MOU. Any changes/amendments to this MOU is not in conformance to this section shall be deemed to be void-ab-initio.

11. Intellectual Proprietary Rights:

All intellectual or proprietary property and information, supplied or developed by either Party shall be and remain the sole and exclusive property of the Party who supplied or developed same. Upon termination of this MOU and upon written request, the Party in receipt of the requesting Party's intellectual or proprietary property and/or information pursuant to this MOU shall return such information to the requesting Party.

12. Confidential Information: Both parties undertake to each other to keep confidential all information (written /oral) concerning the business and affairs of the other, which has been obtained or received during the course(s) of performance here under, save that which is in consequential or obvious;

- a. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained.
- b. Both parties agree not to deal directly or enter into any business agreement with any of the partners or associates or customers of either party during the term of the agreement and also after the agreement have been terminated, not earlier than two years from the date of termination.

13. Force Majeure:

- a. Neither party to this MOU shall be liable for any failure or delay on its part in performing any of its obligations under this MOU, if such failure or delay shall be result of or arising out of Force Majeure conditions and, provided that the party claiming Force Majeure shall use its best efforts to avoid or remove such cause of non-performance and shall fulfil and continue performance hereunder with the utmost dispatch whenever and to the extent such cause or causes are removed.

b. Any extraordinary event, which cannot be controlled by the parties, shall for the purpose of this MOU be considered as a Force Majeure event. Such events include acts of God, acts or omissions of any Government or agency thereof, compliance with rules, regulations or order of any Government Authority. Provided however, if either party claims that existence of any of the aforesaid conditions is delaying or disabling the performance by said party of its obligations under this MOU, such party shall give immediate notice to the other party of the existence of such conditions whose existence are claimed to delay or disable the performance of obligations as aforesaid.

14. Any dispute arising out of, in relation to or in respect to this MOU shall be settled through mutual consultation and agreement, by the Parties to this MOU.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered into at Chennai on the 01st day of June 2017 ("Effective Date")

BETWEEN

APOLLO SHINE FOUNDATION, a not for profit company incorporated under the Companies Act, 1956 and having its office at Ali Towers, No. 55, Greams Road, Chennai – 600006, hereinafter referred to as "**Foundation**" which expression shall unless repugnant to or inconsistent with the context or meaning thereof, mean and include its successors in office and permitted assigns of the **FIRST PART**,

AND

Dhanraj Baid Jain College, registered under **University of Madras**, having its office at Rajiv Gandhi Salai, Jyothi Nagar, Thoraipakkam Chennai- 600 097, represented by its **Chairman, Shri Lalchand Munoth**, hereinafter referred to as "**Institution**" which expression shall unless repugnant to or inconsistent with the context or meaning thereof, mean and include its successors in interest and permitted assigns of the **SECOND PART**

"Foundation" and "Institution" shall be individually referred to as a "Party" and collectively as "Parties"

RECITALS

WHEREAS:

- (a) The Foundation is a not for profit organization incorporated with the vision to provide quality and comprehensive healthcare services that include facilities and services for creating awareness, prevention, treatment, diagnosis and care for illnesses, to children, adolescents and young adults, irrespective of caste, religion, sex or financial means. The Foundation intends to provide subsidized/free healthcare packages to such children, adolescents and young adults;
- (b) The Foundation has set-up the Apollo SHINE Foundation Clinic, **situated at Door no 29, Khader Nawaz Khan Road, Nungambakkam, Chennai - 600034**, and has engaged on its payroll medical practitioners and/or paramedics and/or other healthcare professionals to deliver such healthcare services.
- (c) The Institution is an educational institution, and in order to promote the health and well-being of its students, the Institution is interested in collaborating with a healthcare service provider to provide a comprehensive health services to all the students of its Institution.
- (d) The Foundation has developed a comprehensive program viz., "Campus Health Initiative" which includes health screening by its medical professionals supported by its paramedics, providing support and setting-up infrastructure for first aid facilities at each educational institution. It also aims at inculcating habits of discipline, focus and moderation that will lead to a life time of good health among students of educational institutions by introducing a holistic approach to healthcare such as awareness on the benefits of Yoga, hygiene, dietary habits, exercise. The program envisages delivery of healthcare services at a nominal rate for students and as required, free treatment of underprivileged students.
- (e) Institution is desirous of implementing all or some components of the SHINE program in its Institution and the Foundation has agreed to provide its healthcare services as per the terms stated in the Annexure to this MoU.

NOW THIS MOU WITNESSETH AS FOLLOWS:

1. SCOPE OF THE MoU

- a. This MoU shall govern the relationship between the Foundation and the Institution and the manner in which it shall deliver the SHINE program in its Institution.
- b. The SHINE program shall deliver services related to Health Screening, Health Awareness, Preventive medicine, pre-emptive health checks, patient stabilization in case of emergency and administration of a First-Aid room on campus.
- c. SHINE is also extended to the staff/teachers of the Institution, and certain underprivileged students who are economically backward.
- d. The enrolled students, staff and teachers shall be issued an ID card called the Shine Privilege card to identify them to avail the services and benefits.




2. OBLIGATIONS OF THE FOUNDATION

The Foundation shall ensure that:

- 2.1. It shall deliver a comprehensive coverage of services under the SHINE Program, in a phased manner in consultation with the Nominated Representatives of the Institution. The Nominated Representative for the purpose of this MoU shall be the Principal of each of the Institutions.
- 2.2 It shall set-up a First Aid room to administer its services to the Members in a location indicated by the Institution and space provided by it.
- 2.3. The First-Aid room will be equipped by the Foundation with the consumables that include first-aid kits and non-prescription medicines required for the day-to-day running of the room and administering basic first-aid to Members. A trained nurse/paramedic shall be stationed at the First-Aid room to provide such care.
- 2.4 The SHINE First Aid Room at the institution provided by the Foundation shall function during the Institution's working days and working hours. The foundation will intimate the Nominated Representative in advance if the room cannot be operational for any reason.
- 2.5. It will conduct the Health Screening on campus for Members once every year which will include basic parameters such as Height, weight, waist circumference, body mass index, vision, dental, blood pressure (adults only) sugar check (adults only) and consultation with our Doctors.
- 2.6. Informative literature and Preventive health advisory on various health issues is provided and it will conduct various health talks on holistic healthcare as mentioned above and conduct Basic Life Support awareness programs for the benefit of the Members in consultation with the Nominated Representative.
- 2.7. Health Records of the Members will be accessible to the Members, their parent/guardian subject to legally acceptable terms of confidentiality, in electronic format. Immediately on expiry or termination of this MoU, the Foundation will delete access to Health Records to former Members, or their parents/legal guardians to ensure data safety. Medical Records shall mean a record of the Member's medical information such as medical history, care or treatment received, test results, diagnoses, digital recordings, and medications taken.
- 2.8. Written consent as prescribed by law is obtained from parents/legal guardians of students, staff/teacher consenting to undergo the health-check services under the Program. The Nominated Representative shall ensure that Members complete and hand-over the written consent/authorization form to the Foundation.
- 2.9. The Foundation will not be obliged in any manner whatsoever to deliver services under the Program to any Member on non-receipt of such written consent/authorization.
- 2.10 In case an emergency situation arises when a Member requires medical care beyond first aid, the Foundation nurse shall in consultation with a SHINE physician, call for an ambulance and inform the Nominated Representative of the Institution. The Nurse in consultation with the Foundation Doctor shall complete an assessment form with the details of the Member including a preliminary assessment of the Member's condition and handover the same to the Nominated Representative/ parent/guardian/ of the Member.





3. OBLIGATIONS OF THE INSTITUTION

3.1. Institution shall ensure that all students are enrolled as Members in the SHINE Program.

3.2. Institution shall ensure that the terms and conditions / services of SHINE as per this MOU are duly communicated to the Member/parent/guardian and shall ensure it hands over the information sheets provided by SHINE to each Member/parent/guardian.

3.3. Institution shall nominate the Nominated Representative to be single point of contact to coordinate the SHINE program with the Foundation.

3.4. The Institution shall provide the Foundation of the list of Members, contact details and other particulars.

3.5. Institution shall provide a room of not less than 100 square feet, to the Foundation to run the First-Aid room and shall also provide other necessary facilities as shall be indicated by the Foundation, and ensure that the room is maintained with such facilities.

3.6. The Institution shall ensure that the Members complete and return all necessary documentation including signed Informed Consent forms provided by the Foundation.

3.7. The Institution shall pay the Foundation for services rendered under the SHINE program, in the following manner: The Payment for the services under SHINE may be paid by Cheque / Demand Draft payable to "**Apollo SHINE Foundation**" payable at Chennai, payable at the time of commencement of the SHINE program.

4. GENERAL CONDITIONS

The Parties agree that no implied or express license to any of the other Party's branding is being granted hereunder and the Parties shall not use any trade mark of the other Parties except in accordance with this MoU or unless authorized by such Party in writing.

5. TERM AND TERMINATION

5.1. This MoU shall be valid from the date of commencement of the academic year and for a period of one year(s). The MoU shall be renewed for a further period at the option of both the Parties.

5.2. Notwithstanding the above, either Party may terminate this MoU by serving a notice of 30 (thirty) days to the other Party.

5.3. Notwithstanding anything contained in this MoU, this MoU shall terminate upon the occurrence of the earlier of any of the following:
(a) The insolvency, bankruptcy, dissolution, or liquidation of either Party.

5.4. Upon expiration or early termination, the Parties will not be liable for any ongoing obligations except for the surviving obligations under this MoU on the date of such termination.

5.5 Upon expiration or early termination, both Parties shall return or destroy all Confidential Information of the other Party that it possesses and shall confirm such return in writing within 10 business days of expiration or early termination of this MoU. Expiration or early termination of this MoU shall not prejudice any of the Parties' rights and remedies which have accrued as on termination date.

5.6. Immediately on expiry or early termination of this MoU, the Institution shall ensure that it informs the parents/legal guardians that the Program has been discontinued and the Foundation shall ensure that it hands over all the Medical Records to the concerned Members, parents/legal guardians within a week from the expiry or early termination of this MoU.

5.7. Immediately on expiry or early termination of this MoU, the Institution shall permit the Foundation to remove all its equipment and utilities from its premises permanently.

6. CONFIDENTIAL INFORMATION

6.1 Confidential Information in relation to a Party means:

- a) Any Medical Records of students
- b) any information obtained from, or provided by, the Party in the course of negotiating or performing this MoU which is confidential in nature and/or designated by the Party as confidential
- c) any information about the existence or terms of this MoU
- d) any information concerning the organization, business, intellectual property, technology, trade secrets, know-how, finance, transactions or affairs of Parties (whether conveyed in written, oral or in any other form)
- e) any information or materials prepared by or for a Party that contain or otherwise reflect, or are generated from Confidential Information; and but does not include any information that was in the public domain when it was provided to the other Party becomes, after being provided to the other Party, part of the public domain, except through disclosure contrary to this MoU was in the other Party's possession when it was provided to it and was not otherwise acquired from the Party directly or indirectly; or was lawfully received from another person having the unrestricted legal right to disclose that information without requiring the maintenance of confidentiality.

6.2. Both Parties shall ensure that all of its personnel are bound by confidentiality terms which are no less stringent than those imposed on either Party under this MoU.

6.3. Both Parties shall comply with all relevant obligations under applicable law pertaining to security practices to be followed with regard to medical information made available to such Party.

6.4. This Section shall be a continuing obligation on the Parties notwithstanding the expiry or termination of this MoU.

7. AUTHORITY

Each Party represents and warrants that it has the authority to enter into, and the respective signatories are authorized to sign and that it has received all necessary approvals to execute the MoU.

8. INDEMNITY

Both Parties agree to fully and completely indemnify, defend and hold harmless, the other Party, affiliates, and permitted assigns from and against all claims, losses, costs, liabilities, damages or deficiencies including legal fees and expenses (hereinafter collectively referred to as 'Losses') suffered, incurred or paid, directly or indirectly, by the other Party, as a result of, in connection with or arising out of any claims by any person with respect to material breach of any of the provisions of this MoU or material breach of any applicable laws, regulations and globally accepted ethical norms and consenting practices.

9. MEDIATION, ARBITRATION AND JURISDICTION

In the event of a dispute arising out of or relating to this MoU, including any question regarding its existence, validity or termination, the parties shall seek settlement of that dispute by mutual discussions.

If the dispute is not settled by mutual discussions, the dispute shall be referred to and finally resolved by arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The Tribunal shall consist of a sole arbitrator. The language of the arbitration shall be English. Judgment on the arbitrator (s) award may then be entered in the Courts at Chennai. The Courts in Chennai shall have exclusive jurisdiction to entertain any application/petition relating to the dispute between the Parties.

10. NOTICES



11. GENERAL.

In the event that any provision of this MoU is held unenforceable for any reason, the remaining provisions of this MoU shall remain in full force and effect. Any amendment to this MoU must be in writing and must be signed by the parties. No delay or omission by either party in exercising any right hereunder shall be construed as a waiver. The waiver by either party of a breach or violation of any provision of this MoU shall not operate as or be construed to be a waiver of any subsequent breach of the same or other provision hereof.

12. COMPLETE AGREEMENT; AMENDMENT.



This Memorandum of Understanding is made at **Chennai** on **10th** day of **August 2017**.

BETWEEN

Dhanraj Baid Jain College, located at Jyothi Nagar, Thoraipakkam, Chennai-600097, herein after referred to as "**D.B. Jain College**" (Which term shall so far as the context admits be deemed to mean and include its successors and assigns) of the **First Part**,

AND

M/s. Mahindra Pride School, Naandi Foundation a **Public Charitable Trust incorporated under the Indian Trusts Act, having its registered office at 502, Trendset Towers, Road No 2 , Banjara Hills, Hyderabad – 500 034, Telangana** , herein after referred to as “MPS” (which term shall so far as the context admits be deemed to mean and include its successors, administrators, executors and assignees) of the **Second Part**.

WHEREAS:

1. **Dhanraj Baid Jain College (Autonomous)** is affiliated to University of Madras ,Chennai. Dhanraj Baid Jain college offers Degree programmes in the various fields of Arts & Science like B.Com, BBA, BSc, BCA etc.
2. MPS is a Training Partner for providing training to the students under the CSR initiative of the Mahindra Group
3. **Dhanraj Baid Jain College** is willing to enter into a Memorandum of Understanding (MOU) with MPS to train its students under the aforesaid CSR Initiative Program that will train and make the students employable.
4. This MOU is entered for the first time since the Programme was already started. The training program is a MPS funded program for the social cause.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. Objective:

The objective of this MOU is to train the students under the CSR-Initiative program, (hereinafter referred to as the “Training Program”) to be conducted at **Dhanraj Baid Jain College** premises.

2. Period of MOU:

This MOU shall come into force with effect from the date of execution and shall remain valid for a period of Three years from such date after which the same may be reviewed by either party. However, if the same is not renewed this arrangement will be deemed terminated on the expiry of the said duration period.

Mahindra Pride School was conducted Free Training Program to the Final Year Students of D.B.Jain College from 2016-17 onwards.

3. Roles & Responsibilities of Dhanraj Baid Jain College :

- a. Dhanraj Baid Jain College shall be responsible to nominate one person with adequate accountability and responsibility to coordinate the Training Program. The person so appointed would act as the single point of contact (SPOC) for the proposed Programme.
- b. It would be the responsibility of Dhanraj Baid Jain College to ensure that proper publicity of the Program is made through College website.
- c. To encourage the Students to register for the Program by informing them about the benefits of the program.
- d. To make available the infrastructure (including IT infrastructure, applications and connectivity) required for conduct of the Training Program. The infrastructure requirements such as LCD projectors, classrooms, computer labs, PC with internet connectivity, etc., are provided by Dhanraj Baid Jain College based upon the availability of resources.
- e. To provide all the support services and facilities to MPS during the conduct of the said Training Program.
- f. To coordinate with MPS and facilitate the conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by MPS, as per schedule communicated by MPS .
- g. Dhanraj Baid Jain College will have the absolute right to dismiss a candidate if the candidate does not align with rules and regulation of the institution, and of the state.

4. Roles & Responsibilities of MPS:

- a. MPS shall be responsible to provide the training as per Training Program requirements and curriculum for delivery.
- b. MPS will provide suitable faculty for conducting the training exclusively for classroom training.
- c. MPS will arrange for assessment of its own and also arrange external assessment as required.

5. Other Terms & Conditions:

Following are the other terms and conditions of MOU:

- a. Batch Size: The batch size would need to be a minimum of 40 students .
- b. Each student would be made available for the Training Program for specified number of

hours per day for the entire duration of the Training Program.

- c. The students enrolled should complete the training as scheduled.
- d. Attendance will be responsibility of Dhanraj Baid Jain College
- e. Program Coordinator to be appointed by college
- f. Training & Placement Officer's active support and participation is required for the smooth and efficient conduct of the program.

6. Commercials:
